EB-2022-0017

GRANDBRIDGE ENERGY INC.

**Application for rates and other charges to be effective
January 1, 2023**

1. OVERVIEW

The Ontario Energy Board is approving changes to the rates that GrandBridge Energy Inc. (GrandBridge Energy) charges to distribute electricity to its customers, effective January 1, 2023.

As a result of this Decision, there will be a monthly total bill increase of \$1.45 in the Brantford Power rate zone and an increase of \$1.13 in the Energy+ rate zone for a residential customer consuming 750 kWh. These changes do not factor in applicable taxes or the Ontario Electricity Rebate.

2. CONTEXT AND PROCESS

On March 17, 2022, the OEB approved the amalgamation of Brantford Power Inc. and Energy+ Inc.¹ Effective May 2, 2022, both utilities operate under the name GrandBridge Energy Inc.² As part of the amalgamation approval, the OEB determined that GrandBridge Energy would maintain two separate rate zones, the Brantford Power rate zone and the Energy+ rate zone, for a ten-year deferral period, at which point GrandBridge Energy's rates will be rebased.

GrandBridge Energy serves approximately 109,000 mostly residential and commercial electricity customers. The service territory for the Brantford Power rate zone is the City of Brantford. The service territory for the Energy+ rate zone encompasses the City of Cambridge, Township of North Dumfries, and County of Brant (including a newly annexed section of the City of Brantford).

GrandBridge Energy filed its application on August 3, 2022, under section 78 of the *Ontario Energy Board Act, 1998* and in accordance with Chapter 3 of the OEB's [Filing Requirements for Incentive Rate-Setting Applications](#) (Filing Requirements). The application was based on the Price Cap Incentive Rate-setting (Price Cap IR) option.

The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) approved by the OEB.³ It involves the setting of rates through a cost of service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing adjustment years.

The OEB follows a standardized and streamlined process for hearing IRM applications. In each adjustment year, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor will then review, complete, and include the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

The application was supported by pre-filed written evidence and a completed Rate Generator Model and as required during the proceeding, GrandBridge Energy updated and clarified the evidence.

3. DECISION OUTLINE

Each of the following issues is addressed in this Decision, together with the OEB's findings.

- Annual Adjustment Mechanism
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Lost Revenue Adjustment Mechanism Variance Account

Instructions for implementing GrandBridge Energy's new rates and charges are set out in the final section of this Decision.

This Decision does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges⁴ and loss factors⁵, which are out of the scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

4. ANNUAL ADJUSTMENT MECHANISM

GrandBridge Energy has applied to change its rates, effective January 1, 2023, based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.⁶

Brantford Power Rate Zone

The components of the Price Cap adjustment formula applicable to the Brantford Power rate zone are set out in the table below. Inserting these components into the formula results in a 3.40% increase to GrandBridge Energy's rates in the Brantford Power rate zone: **3.40% = 3.70% - (0.00% + 0.30%)**.

Energy+ Rate Zone

The components of the Price Cap adjustment formula applicable to the Energy+ rate zone are set out in the table below. Inserting these components into the formula results in a 3.70% increase to GrandBridge Energy's rates in the Energy+ rate zone: **3.55% = 3.70% - (0.00% + 0.15%)**.

An inflation factor of 3.70% applies to all IRM applications for the 2023 rate year.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2023 rate year. The stretch factor component of the X-factor is distributor-specific. The OEB has established five stretch factor groupings, ranging from 0.00% to 0.60%. The stretch factor assigned to any distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario.

As part of the decision and order approving the amalgamation of the former Brantford Power Inc. and Energy+ Inc., the OEB approved the use of a combined stretch factor for GrandBridge Energy to use in IRM rate applications as soon as a stretch factor is available for the merged company.¹⁰ The stretch factor assignments for the 2023 rate year are based on pre-amalgamation total cost performance during the 2021 calendar year. Accordingly, a standalone stretch factor is applied to each rate zone in this proceeding. The stretch factor assigned to the Brantford Power rate zone is 0.30%, resulting in a rate adjustment of 3.40%. The stretch factor assigned to the Energy+ rate zone is 0.15%, resulting in a rate adjustment of 3.55%.

Findings

GrandBridge Energy's request for a 3.40% rate adjustment for the Brantford Power rate zone and a 3.55% rate adjustment for the Energy+ rate zone is in accordance with the annually updated parameters set by the OEB. The adjustments are approved, and GrandBridge Energy's new rates shall be effective January 1, 2023.

5. RETAIL TRANSMISSION SERVICE RATES

The Brantford Power rate zone is partially embedded within the distribution system of the Energy+ rate zone. The Energy+ rate zone is partially embedded within Hydro One Networks Inc.'s distribution system and within the distribution system of the Brantford Power rate zone. Both rate zones are also partially connected directly to the transmission system.

To recover its cost of transmission services, GrandBridge Energy requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host-distributor RTSRs.

Findings

GrandBridge Energy's proposed adjustment to its RTSRs is approved.

The RTSRs were adjusted based on the current OEB-approved UTRs and 2022 host-RTSRs.¹¹

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs and host-RTSRs take effect during GrandBridge Energy's 2023 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

6. GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor can justify why balances should not be disposed.¹² If the balance does not exceed the threshold, a distributor may still request disposition.¹³

Brantford Power Rate Zone

The 2021 year-end net balance for GrandBridge Energy's Group 1 accounts that are eligible for disposition in the Brantford Power rate zone, including interest projected to December 31, 2022, is a debit of \$567,945, and pertains to variances accumulated during the 2021 calendar year. This amount represents a total claim of \$0.0006 per kWh, which does not exceed the disposition threshold, and GrandBridge Energy has not requested the disposition of the Group 1 accounts in the Brantford Power rate zone.

Energy+ Rate Zone

The 2021 year-end net balance for GrandBridge Energy's Group 1 accounts that are eligible for disposition in the Energy+ rate zone, including interest projected to December 31, 2022, is a debit of \$2,517,423, and pertains to variances accumulated during the 2021 calendar year. This amount represents a total claim of \$0.0016 per kWh, which exceeds the disposition threshold.

The accounts requested for disposition exclude Account 1580 – RSVA Wholesale Market Service Charge, Account 1589 – RSVA Global Adjustment, and Sub-Account 1595 (2018). As part of its pre-filed evidence, GrandBridge Energy identified that one of the main drivers for a large residual balance remaining in sub-account 1595 (2018) was an accounting error associated with billing customers, who transitioned between Class A and Class B, their respective Global Adjustment and Capacity Based Recovery charges.¹⁴ GrandBridge Energy subsequently submitted a request to withdraw disposition of these accounts and noted that it intends to file a separate application for disposition of these amounts.¹⁵

Findings

For the Brantford Power rate zone, the OEB finds that the account balances appear reasonable and the threshold calculation is correct. No disposition is required at this time, as the disposition threshold has not been exceeded and the distributor did not request disposition.

For the Energy+ rate zone, the OEB accepts GrandBridge Energy's proposal to withdraw disposition of Accounts 1580, 1589 and 1595 (2018), and to address these variances as part of a separate application. The OEB approves the disposition of a debit balance of \$2,517,423 as of December 31, 2021, including interest projected to December 31, 2022, for the other Group 1 accounts on a final basis.

Table 6.1 identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting*

Procedures Handbook for Electricity Distributors.¹⁶ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through final rate riders, charges, or payments, as calculated in the Rate Generator Model. The final rate riders, charges, and payments, as applicable, will be in effect over a one-year period from January 1, 2023 to December 31, 2023.¹⁷

7. LOST REVENUE ADJUSTMENT MECHANISM VARIANCE ACCOUNT

The OEB has historically utilized a Lost Revenue Adjustment Mechanism Variance Account (LRAMVA) to capture a distributor's revenue implications resulting from differences between actual and forecast conservation and demand management (CDM) savings included in its last OEB-approved load forecast. The use of the LRAMVA is no longer the default approach for CDM activities.¹⁸

Distributors delivered CDM programs to their customers through the Conservation First Framework (CFF) that began on January 1, 2015 until March 20, 2019, when the CFF was revoked.¹⁹

Distributors filing an application for 2023 rates are required to seek disposition of all outstanding LRAMVA balances related to program savings related for CFF programs or other conservation programs they delivered, unless they do not have complete information on eligible program savings.²⁰

Distributors are also eligible under the LRAM for persisting impacts of conservation programs until their next rebasing. The OEB provided direction for distributors to seek approval of LRAM-eligible amounts for 2023 onwards on a prospective basis, and a rate rider in the corresponding rate year, to address amounts that would otherwise be recorded in the LRAMVA for all years until their next rebasing application.²¹

GrandBridge Energy did not apply for disposition of any LRAM-eligible amounts as part of this proceeding. GrandBridge Energy explained that, as part of its efforts to wind down CDM programs, it identified projects in its service territory which were placed in-service as early as 2019 for which final savings results are not yet verified, and that the project applicants with outstanding project information are some of GrandBridge Energy's larger customers. GrandBridge Energy stated that it is premature to make final claims for all prior outstanding program years, without final information available regarding the savings for potentially significant in-service projects.

GrandBridge Energy also explained that, while there are multiple factors that have increased the complexity associated with calculating and supporting its potential

LRAMVA claim (e.g., the IESO's discontinuation of annual reporting of CDM at the distributor level and the need to calculate LRAMVA claims for multiple rate zones), its resources for doing so have been strained. This is largely due to the time commitments needed to support the GrandBridge Energy amalgamation – notably the regulatory affairs staff, as well as a recent vacancy in this area.²²

Accordingly, GrandBridge Energy requested that the OEB permit it to submit its LRAMVA claim in a future proceeding, once accurate and comprehensive program results are available to support the LRAMVA calculations.

Findings

The OEB grants GrandBridge Energy's request to defer disposition of the LRAMVA to a future proceeding, when complete information on eligible program savings is available to support that claim.

8. IMPLEMENTATION

This Decision is accompanied by a Rate Generator Model, applicable supporting models, and a Tariff of Rates and Charges (Schedule A). The Rate Generator Model also incorporates the rates set out in Table 8.1.

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP, WMS, and CBR rates were set by the OEB on December 16, 2021 and July 12, 2022.²³

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB at \$0.42 on September 8, 2022.²⁴

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,²⁵ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. Distributors shall apply the updated value, if applicable, following the OEB’s announcement of the microFIT charge for the 2023 rate year.

9. ORDER

THE ONTARIO ENERGY BOARD ORDERS THAT

1. The Tariff of Rates and Charges set out in Schedule A of this Decision and Rate Order is approved effective January 1, 2023, for electricity consumed or estimated to have been consumed on and after such date. GrandBridge Energy shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.

RESIDENTIAL SERVICE CLASSIFICATION

Residential refers to the supply of electrical energy to detached, semi-detached and row-housing units (freehold or condominium). This classification typically refers to an account taking electricity at 750 volts or less where electricity is used exclusively in a separate metered living accommodation. Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex, or quadruplex house, with a residential zoning. Separate metered dwellings within a town house complex, condominium, or apartment building also qualify as residential customers. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.

It should be noted that this schedule does not list any charges, assessments, or credits that are required by law to be invoiced by a distributor and that are not subject to Ontario Energy Board approval, such as the Global Adjustment and the HST.

GENERAL SERVICE LESS THAN 50 KW SERVICE CLASSIFICATION

General Service refers to the supply of electrical energy to business customers, to bulk-metered residential buildings and to combined residential and business or residential and agricultural buildings. Apartment buildings that are bulk metered will be billed at the appropriate General Service rate. This classification refers to a non-residential account taking electricity at 750 volts or less whose average monthly peak demand is less than, or is forecast to be less than, 50 kW. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.
