

# NOTICE OF A RATE HEARING

## GrandBridge Energy Inc. has applied for funding for its Non-Wires Solutions Program

GrandBridge Energy Inc. (GrandBridge Energy or GBE) proposes to procure 20 MW of capacity through a non-wires solution (NWS) capacity auction for three years (2026 to 2028), during which time a traditional infrastructure investment can be planned and constructed. GrandBridge Energy will reassess the need for the NWS beyond 2028, drawing on experience from the NWS Program's first years. GrandBridge Energy submits that the NWS Program has a benefit-to-cost ratio of 1.97.

If the application is approved as filed, a GrandBridge Energy typical residential customer and a typical general service customer in the GBE (E+) rate zone (i.e., the service territory for the City of Cambridge, Township of North Dumfries and County of Brant) would see the following increase effective May 1, 2026:

<b>Residential (750 kWh)</b>	<b>\$0.60 per month</b>
<b>General Service less than 50kW (2,000 kWh)</b>	<b>\$0.80 per month</b>

Other customers, including businesses, will also be affected.

GrandBridge Energy has also applied for approval to establish a NWS Deferral and Variance Account- the NWS Program Costs Variance Account.

It's important to review the application carefully to determine whether you may be affected by the proposed changes.

### YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.
